Eligibility

1. Candidates for the Research Medal are put forward by nomination only.
2. The Research Medal is open to all TSANZ members, including Associate members.
3. The nominee must be a financial member for the entire year that they are nominated, as well as the year they receive the award.
4. Both nominators must be financial members in the year the nomination is submitted.

Criteria

Nominations will be assessed by the TSANZ Board based on the below criteria. The decision of the Board is final.

Publications	30
Grants	20
Peer Recognition	10
Prizes and Awards	15
Research Translation	15
Research Training	5
Professional Activities	5
Total	100

This criteria is based on the National Health and Medical Research Council's Research Performance Descriptors.

Application

- A letter of nomination from two current members of the Society which summarises the nature and significance of the contributions of the nominee. The letter should cover as much information as possible against the criterion above.
- A copy of the nominee's curriculum vitae (no more than 10 pages).
- Nominations will only be accepted in electronic format.
- Nominations are to be submitted to TSANZOffice@thoracic.org.au by **12pm AEDT Monday 7th November 2022**. All components of the nomination must be received by deadline for the application to be accepted. Deadlines will be strictly adhered to.

Award

An official notification letter from the President of TSANZ will be sent to the successful candidate. The successful candidate will be invited to receive their award at the Annual Scientific Meeting. The recipient will also receive a specially engraved medal.
